- 7. - 8. This certificate shall be kept together with the relevant technical documentation in a safe place by the client named on this certificate. Production of this certificate and other documentation may be required by a representative of the EC member state, or UK government.
- 9. This certificate relates only to the condition of the testable items at the time of the certification procedure and is subject to the expiry date shown.
